September 6, 2017

The Atlantic City Council met in regular session in the Council Chambers at City Hall with Mayor Jones presiding. Council Members present were: Jimerson, Somers, Hayes, Hartkopf, Casady, Halder, and Brink. Absent: None.

Motion by Hayes; second by Halder to approve agenda as posted. All ayes. Motion carried.

Motion by Brink; second by Hartkopf to approve consent agenda which included the following: minutes of the August 16, 2017 council meeting, Class C Liquor License and Sunday Sales for Elbow Room, tree trimmer permit for Creative Landscaping. All ayes. Motion carried.

Kris Erickson, Code Enforcement Officer, gave a presentation regarding the city's new reporting software, Action Atlantic/SeeClickFix.

Motion by Jimerson; second by Hartkopf to table Resolution #29-17 "**APPROVAL OF FISCAL YEAR 2017 STREET FINANCIAL REPORT**" until the September 20th meeting. All ayes. Motion carried.

Motion by Somers; second by Brink to approve Resolution #30-17 "**ACCEPTING THE WORK OF THE 2016 STREET AND ALLEY IMPROVEMENTS.**" Ayes: Somers, Hayes, Hartkopf, Casady, Halder, Brink, Jimerson. Nays: None. Motion carried.

City Administrator Lund reported:

- Resident had expressed concern regarding merchandise on the sidewalks in the downtown area; Mayor suggested that the Chamber speak with the downtown businesses
- Received a proposal from Thomas Schroeder to renovate the old YMCA building into multi-residential housing; council discussed potential incentives
- Re-organizing City Administrator records and files

Mayor Jones reminded citizens that with grass growing again due to recent rain, please do not mow grass into the street.

Motion by Casady; second by Hayes to approve the bills totaling \$260,267.24. All ayes.

Council Member Casady raised concerns regarding a large dead tree near the retention pond at the Nishna Hills Golf Course; Mayor replied that it would need to be determined who is responsible for the tree.

Council Member Halder reported a slab behind Dance Atlantic that is washing down as well as a potential downspout issue. Erickson replied that she would look at the situation the next day.

Council Member Jimerson thanked the Police Department for a very successful Family Night Out event.

Motion by Jimerson, second by Halder to adjourn at 6:01 p.m. All ayes.
