Council Member Ashley Hayes announced her resignation as Third Ward Councilwoman, effective following the Council Meeting.

Motion by Casady; second by Somers to accept Council Member Hayes' resignation. All ayes except for Hayes who abstained. Motion carried.

Motion by Brink; second by Somers to send notice that the vacant Third Ward City Council Seat shall be filled by appointment at the June 5, 2019 meeting with resumes due at the Clerk's office by 4:00 p.m. on May 29, 2019. All ayes except for Hayes who abstained. Motion carried.

City Administrator Lund reported that he and Jen McEntaffer, CADCO Executive Director, had met with Jason Kemp, Program Manager for Home Base Iowa, to discuss the city's housing proposal.

Mayor Jones reminded citizens that grass is growing quickly- please keep it cut. He also announced that the Street Department will begin disposing of signs in the Right of Way. Mayor Jones also reported that in the next five years, 80% of the daycare providers in Atlantic could be retiring, which may create a daycare crisis.

Student Representative Report: two boys to state tennis; state track meet this week; last day for seniors; baccalaureate tonight with commencement on Sunday.

City Council Reports: Jimerson- Fire; Somers- Landfill; Hartkopf – Airport; Casady- CPC; Halder- Library, Community Development; Brink-Chamber, Planning & Zoning.

Council Member Halder thanked Council Member Hayes for her years of service to the city.

Grace Garrett had questions about RAGBRAI and was referred to the RAGBRAI Committee.

City Clerk Barrick announced that Nomination Papers for the November election were now available for Wards 1,3,4, and an At-Large Seat, as well as two Park Board seats. Papers cannot be turned in to the County Auditor until August 26th.

Motion by Jimerson; second by Halder to adjourn at 6:22 p.m. All ayes. Motion carried.
