Motion by Somers; second by McCurdy to approve Resolution #27-19 "APPOINTING THE CITY ADMINISTRATOR AS THE OFFICIAL CITY OF ATLANTIC TITLE VI COMPLIANCE OFFICER." Ayes: Somers, McCurdy, Hartkopf, Casady, Halder, Brink, Jimerson. Nays: None. Motion carried.

The Mayor and City Council reviewed the bids for the purchase of the Atlantic Senior Center.

Motion by Hartkopf; second by Jimerson to accept the bid from the Elks' Lodge in the amount of \$55,445 for purchase of the Senior Center. Ayes: Jimerson, Somers, McCurdy, Hartkopf, Casady, Halder. Nays: Brink. Motion carried.

Motion by Brink; second by Halder to approve the second reading of Ordinance No. 983 "AMENDING THE CODE OF ORDINANCES OF THE CITY OF ATLANTIC, IOWA, BY ADDING NEW CHAPTER 168 ENTITLED 'HUMAN HABITATION OF VEHICLES PROHIBITED.'" Motion by McCurdy; second by Hartkopf to appoint Doug Bierbaum to the Planning & Zoning Commission. All ayes. Motion carried.

City Administrator Lund reported:

- Spoke with John Danos regarding the Veteran's Housing Incentive program; moving forward
- Code Enforcement and Park & Rec are working diligently to make the City look nice; weather has been hampering their efforts
- Need to jumpstart working on the FY2021 budget

Mayor Jones reported:

- City is NOT having a city-wide clean up this year; property owners need to clean up their properties including keeping grass mowed
- Looking for 10-14 people to form a Housing Task Force; would like 2 people from Council to serve. Brink and McCurdy volunteered.
- Reminded citizens to not mow grass into the street

City Council Reports:

Brink- Community Protection, Safety; Hartkopf – YMCA; Somers – Cass County Public Safety, Landfill, Personnel & Finance; Jimerson – Park & Rec, Fire

Student Representative Report: State golf; three students to High School Musical Theater awards; three students to National Speech & Debate; softball and baseball; dance recitals.

Council Member Casady reported that he had moved several signs in the right of way. He further mentioned that on a recent trip, he had noticed signs highlighting town activities at interstate exits.

Council Member Brink voiced concerns about recent statistics showing that Atlantic has had an 11% drop in population since the last census.

Mayor Jones reported that asphalt will be delivered in the near future and potholes will be getting fixed.

Motion by Jimerson; second by Halder to adjourn at 6:41 p.m. All ayes. Motion carried.
