Action Items/New Business

1. Buck Creek Dog Park update- approve contract with Snyder & Associates for layout and surveying of area; review the meeting with County engineer regarding the Buck Creek Bridge replacement concerns; Herring & Staashem met with County Engineer and were reassured that the Buck Creek Bridge Project would not interfere with the dog park; Herring asked the Board to approve a contract with Snyder & Associates to do a site plan and layout of the dog park for \$650; Motion to approve the contract by Beane; second by McFadden; motion carried unanimously
2. Urban Forestry Grant update- next training rescheduled for March 17 at the maintenance shop; no action needed
3. Kiddie Korral Update- projected cost of cement sidewalk/service drive; Kiwanis donation; Snyder & Assoc. Engineering Contract; Herring indicated that an estimated cost of cement pad and drive would be in the range of \$20,000; Herring recommended approval of a site plan development, grading plan, topographical survey, bid documents and cost estimates be approved with Snyder & Associates for a fee of \$2850; Beane motion to approve; second by Strong; motion carried unanimously
4. Camblin Shelter Refurbishment Update- power wash, prime & paint, roof, electrical, water fountain & jug filler
5. Playground Equipment at Little League & Kiwanis donation; the city will maintain and purchase from Boland Recreation playground to be installed at the Atlantic Little League Complex; the park and recreation department maintains the complex and recommends the purchase and installation of playground equipment at the complex; Atlantic Little League and the Kiwanis Club will donate the money to the city for the equipment; motion to approve by Smith; second by Beane; motion carries unanimously
6. Summer Recreation Programs & Swimming Pool Recommendations; Nishna Valley YMCA contract; motion to approve the YMCA Management contract as presented; motion by Strong; second by McFadden; motion carries unanimously; and the summer recreation program as presented; motion to approve by Beane; second by Smith; motion carried unanimously
7. Sign for the Parks and Recreation Building; the Directors will be working with Bill Casteel of Atlantic Signs to come up with some concepts to present to the board at the next month's meeting
