

Tuesday, November 10, 2015 **CANVASS OF CITY ELECTIONS OF NOVEMBER 3, 2015**

The Cass County Board of Supervisors met as ex-officio Board of Canvassers with all members present: Frank Waters, Chair; Duane McFadden, Charles Rieken, Gaylord Schelling and Mark Wedemeyer.

At 8:00 A.M. the cities conducting elections under chapters 44 and 45 of the Code of Iowa were canvassed. After inspection of the TALLY BOOKS from the November 3, 2015 regular CITY ELECTION, the Board declared the following candidates elected as shown on the abstract and authorized the Auditor to issue the abstract and certificates of election:

CITY OF ANITA

=====

For the office of ANITA MAYOR, 1 to be elected, there were 219 votes cast as follows:

Ben Daughenbaugh	received 59 votes,
Timothy Miller	received 160 votes, and
(write-in) scattering	received 0 votes.

We therefore declare Timothy Miller duly elected to the office of ANITA MAYOR, for the term of four years.

For the office of ANITA CITY COUNCIL AT LARGE, 2 to be elected, there were 348 votes cast as follows:

Jeff Bohnsack	received 160 votes,
Thomas R. Harris	received 170 votes, and
(write-in) scattering	received 18 votes.

We therefore declare Jeff Bohnsack and Thomas R. Harris duly elected to the office of ANITA CITY COUNCIL AT LARGE, for the term of four years.

CITY OF ATLANTIC

For the office of ATLANTIC CITY COUNCIL AT LARGE, 1 to be elected, 700 votes were cast as follows:

Dana Halder received	685 votes, and
scattering received	15 votes.

We therefore declare Dana Halder duly elected to the office of ATLANTIC CITY COUNCIL AT LARGE, for the term of four years.

For the office of ATLANTIC CITY COUNCIL FIRST WARD, 1 to be elected, 81 votes were cast as follows:

For the office of ATLANTIC CITY COUNCIL FOURTH WARD, 1 to be elected, there 165 votes cast as follows:

Linda J. Hartkopf received	160 votes, and
scattering received	5 votes.

We therefore declare Linda J. Hartkopf duly elected to the office of ATLANTIC CITY COUNCIL FOURTH WARD, for the term four years.

For the office of ATLANTIC CITY COUNCIL FIFTH WARD (vacancy term), 1 to be elected, there 196 votes cast as follows:

Richard D. Casady received	189 votes, and
scattering received	7 votes.

We therefore declare Richard D. Casady duly elected to the office of ATLANTIC CITY COUNCIL FOURTH WARD, for the remainder of the term ending January 2018.

For the office of ATLANTIC PARK & RECREATION BOARD, 1 to be elected, there were 717 votes cast as follows:

PUBLIC MEASURE B ATLANTIC

"Shall the City of Atlantic, in Cass County, Iowa, issue its bonds, paid with local option sales tax (LOST) revenue in an amount not exceeding the amount of \$875,000 for the purpose of paying for the cost of restoring the historic ballroom/theater and creating a multi-purpose facility on the second and third floors of City Hall?, there were 799 votes cast as follows:

For the question, there were 282 votes.

Against the question, there were 517 votes.

We therefore declare the public measure NOT to be adopted.

CITY OF CUMBERLAND

=====

For the office of CUMBERLAND MAYOR, 1 to be elected, there were 30 votes cast as follows:

Nancy Virginia Coughlin received 25 votes, and
scattering received 5 votes.

We therefore declare Nancy Virginia Coughlin duly elected to the office of CUMBERLAND MAYOR, for the term of two years.

For the office of CUMBERLAND CITY COUNCIL AT LARGE, 2 to be elected, there were 60 votes cast as follows:

Scott W. Becker received 19 votes,
Sandra K. Eversole received 21 votes,
(write-in) Darrin Hardisty received 10 votes,
(write-in) Mike Hill received 10 votes, and
(write-in) scattering received 0 votes.

We therefore declare Scott W. Becker and Sandra K. Eversole duly elected to the office of CUMBERLAND CITY COUNCIL AT LARGE, for the term of four years.

For the office of CUMBERLAND CITY COUNCIL AT LARGE (vacancy term), 1 to be elected, there 20 votes cast as follows:

Catherine Landstreet-Howard received 8 votes,
(write-in) Mary Anstey received 1 vote,
(write-in) Darrin Hardisty received 7 votes,
(write-in) Brad Penton received 1 vote, and
scattering received 3 votes.

We therefore declare Catherine Landstreet-Howard duly elected to the office of CUMBERLAND CITY COUNCIL FOURTH WARD, for the remainder of the term ending January 2, 2018.

CITY OF GRISWOLD

For the office of GRISWOLD MAYOR, 1 to be elected, there were 135 votes cast as follows:

(write-in) Ryan Askeland received 9 votes,
(write-in) Jeb Peck received 106 votes, and
(write-in) scattering received 20 votes.

We therefore declare Jeb Peck duly elected to the office of GRISWOLD MAYOR, for the term of two years.

For the office of GRISWOLD CITY COUNCIL AT LARGE, 3 to be elected, there were 380 votes cast as follows:

Ryan Askeland received 131 votes,
Lisa Cook received 112 votes,
Carmen Sorensen received 102 votes, and

PUBLIC MEASURE C GRISWOLD

"Shall the City of Griswold change the Mayor's term from a two (2) year term to a four (4) year term?"

there were 143 votes cast as follows:

For the question, there were 86 votes.

Against the question, there were 57 votes.

We therefore declare the public measure adopted.

CITY OF LEWIS

For the office of LEWIS MAYOR, 1 to be elected, there were 86 votes cast as follows:

Jon E. Mosier received 80 votes, and

(write-in) scattering received 6 votes.

We therefore declare Jon E. Mosier duly elected to the office of LEWIS MAYOR, for the term of four years.

For the office of LEWIS CITY COUNCIL AT LARGE, 3 to be elected, there were 262 votes cast as follows:

Duane Scott Anderson received 55 votes,

Kristy Bassett received 52 votes,

Marvin Bradfield received 74 votes,

Leroy Easter received 29 votes,

Nona Erickson received 50 votes, and

(write-in) scattering received 2 votes.

We therefore declare Duane Scott Anderson, Kristy Bassett and Marvin Bradfield duly elected to the office of LEWIS CITY COUNCIL AT LARGE, for the term of four years.

Upon the public measure:

PUBLIC MEASURE D LEWIS

"Shall an annual levy, the amount of which will not exceed a rate of twenty-seven cents per thousand dollars of assessed value of the taxable property be authorized for providing moneys for public library services?", there were 89 votes cast as follows:

For the question, there were 41 votes.

Against the question, there were 48 votes.

We therefore declare the public measure NOT to be adopted.

CITY OF MARNE

For the office of MARNE MAYOR, 1 to be elected, there were 30 votes cast as follows:

Randall Baxter received 25 votes, and

(write-in) scattering received 5 vote.

We therefore declare Randall Baxter duly elected to the office of MARNE MAYOR, for the term of two years.

For the office of MARNE CITY COUNCIL AT LARGE, 5 to be elected, there were 165 votes cast as follows:

Alan Cranston received 24 votes,

Kyle Frederiksen received 28 votes,

Lori Holste received 30 votes,

Michael Jensen received 27 votes,

Angela Redler received 22 votes,

(write-in) Mark Opbroek received 14 votes,

(write-in) Jerico Schmitt received 9 votes, and

(write-in) scattering received 11 votes.

We therefore declare Alan Cranston, Kyle Frederiksen, Lori Holste, Michael Jensen and Angela Redler duly elected to the office of MARNE CITY COUNCIL AT LARGE, for the term of two years.

Upon the public measure:

PUBLIC MEASURE E MARNE

"Shall an annual levy, the amount of which shall not exceed a rate of one dollar and fifty cents per thousand dollars of assessed value of the taxable property in the unified law enforcement district be authorized for providing additional moneys needed for unified law enforcement services in the district?", there were 33 votes cast as follows:

For the question, there were 21 votes.

Against the question, there were 12 votes.

We therefore declare the public measure adopted.

For the office of MASSENA MAYOR, 1 to be elected, there were 30 votes cast as follows:

Linda Reineke received 29 votes, and

(write-in) scattering received 1 votes.

We therefore declare Linda Reineke duly elected to the office of MASSENA MAYOR, for the term of two years.

For the office of MASSENA CITY COUNCIL AT LARGE, 3 to be elected, there were 91 votes cast as follows:

Micah Lee received 32 votes,
