Wednesday, January 11, 2017

The Cass County Board of Supervisors met at 8:30 a.m. with all members present: Gaylord Schelling, chair; Steve Baier, Stephen Green, Frank Waters and Mark Wedemeyer. Agenda upon motion by Waters, 2nd by Green was approved. Minutes of January 3, 2017 upon motion by Wedemeyer, 2nd by Baier were approved.

At 8:30 a public hearing on an application of Fagin Farms and Elite Octane for a change in zoning classification was conducted. Zoning Administrator Rich Hansen reported that the Zoning Commission met on 01/05/17 and recommended approval. No written or verbal objections were filed. Purpose of the requested change of zoning is to permit the establishment of an ethanol plant. No objections were filed. After brief discussion, motion by Waters, 2nd by Green to close public hearing. Carried unanimously.

Motion by Wedemeyer, 2nd by Green: The Cass County Board of Supervisors concurs with the recommendation of the Cass County Zoning Commission and approves change in zoning from General Agricultural District to Light Industrial District for parcels described as: 1) Parcel F of the E1/2 of Section 31-77-36, Cass County Iowa as shown in Plat recorded

3) An irregular piece of ground situated in the SE1/4 of the SE1/4 of Section 31-77-36, described as follows: Beginning at a point 330 feet North of the SE Corner of the SE1/4, thence Southwesterly to a point 985 feet West of the SE Corner of the SE1/4 of the SE1/4, thence East on the section line to the North bank of the new channel of the Nishnabotna River, thence Northeasterly along the North bank of the said Nishnabotna River to where the new channel intersects the section line, thence North on the section line to the point of beginning. Said parcel contains 2.4+/- acres.

Motion by Schelling, 2nd by Baier: to allow/disallow family farm credits and to approve agricultural land credits as recommended by the Assessor and the Auditor in accord with <u>Code of Iowa</u> (Chapters 425A & 426) for taxes collectible FY17-18. Carried unanimously.
