January 31, 2017

A meeting of the Board of Supervisors of Cass County, Iowa (the "County"), was held at 8:30 a.m., on January 31, 2017, at the courthouse, Atlantic, Iowa, pursuant to the rules of the Board.

The Chairperson presided and the roll was called, showing Supervisors all present as follows: Gaylord Schelling, chair; Steve Baier, Stephen Green, Frank Waters and Mark Wedemeyer.

The Board of Supervisors investigated and found that notice of the intention of the Board of Supervisors to conduct a public hearing to approve a Development Agreement between the County and Elite Octane, LLC had been published according to law and as directed by the Board and that this is the time and place at which the Board shall receive oral or written objections from any resident or property owner of the County. All written objections, statements, and evidence heretofore filed were reported to the Board, and all oral objections, statements, and all other exhibits presented were considered.

Cass County Auditor Dale Sunderman presented a brief summary of the main points of the current draft of the development agreement including Minimum Actual Value of improvements of \$32,000,000; Priority of County Bonds and payments in lieu of tax if a shortfall occurs; and County agrees to make up to fifteen Tax Incremental Finance (TIF) Payments to the Developer which shall not exceed \$8,500,000 (the "Maximum Payment Total").

The following named persons presented oral objections, statements, or evidence as summarized below; filed written objections or statements, copies of which are attached hereto; or presented other exhibits, copies of which are attached hereto: NONE

There being no further objections or comments, the Chairperson announced that the hearing was closed.

The Cass County Board of Supervisors met at 8:36 a.m. with all members present: Gaylord Schelling, chair; Steve Baier, Stephen Green, Frank Waters and Mark Wedemeyer. Agenda upon motion by Baier, 2nd by Green was approved. Minutes of January 25, 2017 upon motion by Wedemeyer, 2nd by Waters were approved.

County auditor reported that county's legal counsel stated that the Board could either act upon the "Resolution approving Development Agreement with Elite Octane, LLC, Authorizing Tax Increment Payments and Pledging Certain Tax Increment Revenues to the Payment of the Agreement" this morning or table action until a future meeting.

Motion by Waters, 2nd by Green: to table action on the resolution until the February 8, 2017 meeting. After brief discussion, roll call vote. Carried unanimously.
