NOTICE OF PUBLIC LETTING FOR **GLACIER ROAD, BUCK CREEK ROAD AND ECHO ROAD PAVING 2017 - CASS COUNTY, IA** FOR THE CASS COUNTY BOARD OF SUPERVISORS OF ATLANTIC, IOWA.

NOTICE IS HEREBY GIVEN that sealed **bid proposals** will be received by the Board Supervisors of Cass County, Iowa, at the Cass County Courthouse, 5 West 7th Street, Atlantic, IA 50022 until **3:00 P.M.** on **Thursday** the **15th** day of **June, 2017**, relating to the supplying of all labor, equipment, tools and miscellaneous materials necessary for the construction of said project and work incidental thereto as hereinafter generally described and as detailed in the proposed plans and specifications and form of contract for said work, now on file at the Board of Supervisor's Office, Atlantic, Iowa. At such time and place sealed bid proposals received will be opened by the Board's designee, and results announced. Bids received will be considered by the Board at the time and place set out below, immediately following the hearing.

Public Notice is hereby given that at 8:30 A.M. on Wednesday, June 21, 2017, the Board of Supervisors of Cass County of Atlantic, Iowa will, in the Board of Supervisor's Office, Cass County Courthouse, 5 West 7th, Atlantic, Iowa, hold a hearing whereat said Board will resolve to adopt plans, specifications, form of contract and estimate of cost for the construction of the **GLACIER ROAD, BUCK CREEK ROAD AND ECHO ROAD PAVING 2017 - CASS COUNTY, IA** and, at the time, date and place specified above, or at such time, date and place as then may be fixed, to act upon proposals and enter into contract for the construction of said improvements.

The **GLACIER ROAD, BUCK CREEK ROAD AND ECHO ROAD PAVING 2017 - CASS COUNTY, IA** project includes the reconstruction of portions of Glacier Road, Buck Creek Road, and Echo Road from State Highway 83 to County Highway N16, within Cass County, Iowa. Project also includes the installation of turn lanes on N16. Project includes approximately 38,800 SY of 8" PCC Paving, 2.54 MILES of Soil Aggregate Subbase, 1,000 CY of Modified Subbase, 14,000 CY Topsoil, Strip, Salvage and Spread, 40,000 CY of Excavation, 1,200 LF of Roadway and Driveway Culverts, 26,100 LF of Subdrain, surface restoration, and miscellaneous associated work.

The bid shall be allotted 120 working days. The late start date is August 1, 2017.

Liquidated damages in the amount of \$1,000.00 per working day will be assessed for each day that work shall remain uncompleted after the end of the contract period, with due allowance for extensions of the contract period due to conditions beyond control of the Contractor.
