CANVASS OF CITY OF ATLANTIC ELECTION OF NOVEMBER 3, 2009

The Cass County Board of Supervisors met as ex-officio Board of Canvassers with three members present: Duane McFadden, chair; Chuck Kinen and Charles Rieken. Absent: Dave Dunfee and Frank Waters.

At 1 PM the votes cast in the Municipal Election for the City of Atlantic were canvassed according to section 376.9 of the Code of Iowa concerning cities subject to RUN-OFF elections. After inspection of the TALLY BOOKS from the November 3, 2009 regular CITY ELECTION, the Board declared the following candidates elected as shown on the abstract and authorized the Auditor to issue the abstract and certificates of election:

For the office of ATLANTIC CITY MAYOR, 1 to be elected, 1,732 votes were cast as follows:

DAVID R. JONES received 1,500 votes,
PATRICIA ANN SIMMONS received 47 votes,
DAVID L. WHEATLEY received 177 votes, and
Scattering received 8 votes.

We therefore declare DAVID R. JONES duly elected to the office of ATLANTIC CITY MAYOR, for the term of four years.

For the office of ATLANTIC CITY COUNCIL AT LARGE, 1 to be elected, 1,579 votes were cast as follows:

STEVE LIVENGOOD received 1,558 votes, and
scattering received 21 votes.

We therefore declare STEVE LIVENGOOD duly elected to the office of ATLANTIC CITY COUNCIL AT LARGE, for the term of four years.

For the office of ATLANTIC CITY COUNCIL SECOND WARD, 1 to be elected, 252 votes were cast as follows:

LARRY GREUFE received 102 votes,
KATHY SOMERS received 150 votes, and
scattering received 0 votes.

We therefore declare KATHY SOMERS duly elected to the office of ATLANTIC CITY COUNCIL SECOND WARD, for the term of four years.

For the office of ATLANTIC CITY COUNCIL FIFTH WARD, 1 to be elected, there 428 votes cast as follows:

NATHAN BERG received 147 votes,
SHAWN SHOUSE received 279 votes, and
scattering received 2 votes.

We therefore declare SHAWN SHOUSE duly elected to the office of ATLANTIC CITY COUNCIL FIFTH WARD, for the term four years.

For the office of ATLANTIC PARK & RECREATION BOARD, 1 to be elected, there were 1,644 votes cast as follows:

JOLENE S. BOWER received 374 votes,
STUART D. DUSENBERRY received 1,265 votes,
scattering received 5 votes.

We therefore declare STUART D. DUSENBERRY duly elected to the office of ATLANTIC PARKS & RECREATION BOARD, for the term of six years beginning 11/16/09.

Chair declared the canvass completed and adjourned the meeting.
