

**An IOWA WESTERN COMMUNITY COLLEGE BOND ELECTION will be  
conducted on  
Tuesday, December 11, 2018**

**Text of the Public Measure:**

**“Shall the Iowa Western Community College (Merged Area XIII) in the Counties of Adair, Adams, Audubon, Cass, Crawford, Fremont, Harrison, Mills, Monona, Montgomery, Page, Pottawattamie and Shelby, be authorized to remodel, repair, erect, and equip buildings and improve sites, including replacing steam lines at the main campus, contract indebtedness therefore, and issue its school bonds in an amount not exceeding \$11,500,000 for those purposes?”**

Any voter who chooses to vote early may request an absentee ballot. Absentee ballots should be requested as soon as a person decides to vote using this process.

**ONLY FIVE VOTING CENTERS WILL BE USED FOR THIS ELECTION:**

**1. The two VOTING CENTERS for the ATLANTIC COMMUNITY SCHOOL DISTRICT are:**

No. 1: Voters living in Wards 1, 4 and 5 of the City of Atlantic will vote at Heritage House, 1200 Brook Ridge Circle in Atlantic.

No. 2: Voters residing in the remainder of the Atlantic Community School District, being those voters residing in Audubon and Pottawattamie counties; Bear Grove, Benton, Brighton, Cass, Franklin, Grove, Pymosa and Washington townships of Cass County; the City of Marne; the City of Wiota; and Wards 2 and 3 of the City of Atlantic will vote at the Atlantic Public Library (507 Poplar), Atlantic, Iowa.

**2. The two VOTING CENTERS for the CAM COMMUNITY SCHOOL DISTRICT are:**

No. 1- in ANITA: Voters residing in that portion of the CAM Community School District lying in Adair and Audubon counties; Benton, Franklin, Grant and Lincoln townships of Cass County; the City of Anita; and the City of Wiota will vote at the ANITA COMMUNITY CENTER (805 Main St).

No. 2- in MASSENA: Voters residing in that portion of the CAM Community School District lying in Adams County; Bear Grove, Edna, Massena, Noble, Union and Victoria townships of Cass County; the City of Cumberland; and the City of Massena will vote at the MASSENA PUBLIC LIBRARY in Massena (122 Main St).

**3. The VOTING CENTER for the GRISWOLD COMMUNITY SCHOOL DISTRICT is:**

In GRISWOLD- Griswold Community Building, 601 2nd St, Griswold and all voters of the School District will vote there.

Dale Sunderman, Cass County Auditor, reports that the 12/11/2018 **SPECIAL ELECTION** - IOWA WESTERN COMMUNITY COLLEGE BOND QUESTION ballots are now available.

Absentee ballots may be requested by registered voters not going to the assigned voting site on election day December 11, 2018. (Polls will be open from 12 Noon thru 8 P.M.) Voters may vote prior to election day by paper ballot either BY MAIL or alternatively they may vote IN PERSON (Beginning November 13, 2018) AT THE OFFICE OF COUNTY AUDITOR at the Cass County Courthouse, Atlantic, Iowa.

**TO VOTE AN ABSENTEE BALLOT BY MAIL** you must file a request for an absentee ballot.

1. Deliver the absentee ballot request by mail or personal carrier to the auditor's office. You must use the State prescribed absentee ballot request form. A request is not valid unless it includes the SIGNATURE of the person requesting the ballot. Request forms are available at the auditor's office or on the internet at

2. When a request is received by the auditor, a ballot will be mailed if the person is an eligible elector. (A person may register to vote and request a ballot at the same time. A registration form may be sent with your request for an absentee ballot.)

3. With the ballot you will receive instructions for voting the ballot and for returning it.

**TO VOTE AN ABSENTEE BALLOT IN THE OFFICE OF THE CASS COUNTY AUDITOR** you may stop in and request a ballot over the counter. The ballot must then be voted immediately in a voting booth located in that office. The ballot will be sealed in an envelope by the voter, returned to the Auditor, and retained with all other absentee ballots cast by mail or in person. First day to vote in Auditor's office is November 13.

On election day a counting board will process/tabulate all voted absentee ballots.

Office hours for the Cass County Auditor are **Monday thru Friday**, 8 A.M. thru 4:30 P.M. (closed holidays).

In order to vote in this election you must be a resident of the school district and be registered to vote. A person must re-register if that person has moved or has changed his/her name since he/she last registered. Deadline for registration forms to be delivered to the County Auditor's office for this election is Friday, November 30, 2018. Deadline to pre-register in person at the office of County Auditor is also Friday, November 30 (11 days before the election). Same day registration and voting is permitted after voter presents proof of identity and residency. The DATE FOR THE ELECTION is TUESDAY, DECEMBER 11, 2018.
