The Atlantic City Council met in regular session in the Council Chambers at City Hall with Mayor Jones presiding. Council Members present were: Somers, Jimerson, Hayes, Hartkopf, Casady, Halder, and Cord. Absent: none.

Hartkopf moved, Jimerson seconded, to approve the agenda as posted. All in favor.

Hayes moved, Casady seconded, to approve the consent agenda which includes: minutes of the June 1, 2016 Council Meeting, Class C Beer Permit for Olive Street Station, and Cigarette Permits for: Murphy USA, Wal-Mart Supercenter, and Fog Zone. All in favor.

In recognition of the spring Atlantic High School athletic programs, Mayor Jones asked the coaches to introduce the athletes in attendance and speak about the success of their programs. Those doing so were: Boys' Track Coach Alan Jenkins, Boys' Golf Coach Ed DeBenste, Girls' Golf Coach Kathy Hobson, Boys' Soccer Coach Justin Williams, Boys' & Girls' Tennis Coach Mike McDermott, and Girls' Soccer Coach Jordan Newburg.

City Administrator John Lund reported on the Personnel & Finance Committee's recommendation to amend the Personnel Policies.

Somers moved, Hayes seconded, to adopt resolution #16-16 entitled, "**RESOLUTION AMENDING SECTIONS 401 AND 503 OF THE CITY'S PERSONNEL POLICIES.**" All in favor.

Hayes moved, Hartkopf seconded, to approve the Mayor's appointment of Hans Kregel to the Library Board of Directors for the term ending, July 1, 2018. All in favor.

City Administrator John Lund reported on several items including: updating the zoning ordinance and various documents, as recommended by Standards & Poor's in a recent risk analysis.

Mayor Jones announced that City employees have started spraying for mosquitoes.

Wastewater Treatment Plant Superintendent Tim Snyder spoke of how the plant processed the heavy rainfall that occurred in May.

Council Committee reports were as follows: Somers-Cass County Environmental Agency; Casady-Community Promotion Commission; Halder-Cass Atlantic Development Corporation and Library; and Cord-Chamber of Commerce and Planning & Zoning Commission.

Library Director Natalie Struecker gave an update on upcoming activities at the library.

Jimerson moved, Cord seconded, to approve the bills totaling \$41,521.83. All in favor.

Hayes moved, Hartkopf seconded, to approve the Clerk, Treasurer, Budget, General Ledger, Revenue, Airport, and Volunteer Fire Departments for May. All in favor.

Jimerson moved, Halder seconded, to adjourn at 6:07 p.m. All in favor.
