The Atlantic City Council met in regular session in the Council Chambers at City Hall with Mayor Jones presiding. Council Members present were: Jimerson, Somers, Hayes, Hartkopf, Casady, Halder, and Brink. Absent: None.

Harkopf moved, Jimmerson seconded, to amend the agenda by moving item #7. "Presentation by Wastewater Superintendent, Tim Snyder." below item #12. "Public Forum." and to approve the rest of the agenda as posted. All in favor.

Hayes moved, Somers seconded, to approve the consent agenda which included minutes of the September 7, 2016 Council Meeting, Tree Trimmer's Permit for Westphalen Landscaping, and Class C Liquor License for Desperados Investments. All in favor.

Mayor Jones announced that the Halloween "trick or treating" hours will be shall be 5:00 p.m. to 7:30 p.m. on October 31, 2016.

Somers moved, Halder seconded, to adopt resolution #32-16 entitled; **"RESOLUTION AUTHORIZING THE FOLLOWING INSTITUTIONS AS DEPOSITORIES FOR PUBLIC FUNDS FOR THE CITY OF ATLANTIC."** All in favor.
