- Sunnyside Pool Steering Committee Update- Pool Committee is set to meet again to go over Frequently Asked Questions before presenting plans to the public; Staashelm stated that he would like to present plans to the Park and Recreation board at the next January Meeting and then present to city council the following Wednesday; Staashelm said they have not came up with a meeting date yet.
- 2. Approve Lake 2 Trail pay application Part 2- Howrey Construction- Motion to approve Lake 2 Trail pay application made by Strong; Second by McFadden.
- 3. Enhance Iowa Application Update- Staashelm reported to be in contact with the Enhance Iowa Program Manager to discuss the application process; he stated that in the application they will be adding phase 2 to make it one, overall project; Staashelm stated that he will be accepting new support letters from anyone that wants to send one since the name of the program board changed in July they need updated support letters; Staashelm wishes to have the grant done before hand for outsiders to view and make grammatical corrections to the grant.
- 4. Schildberg Recreation Area Campground Update- Staashelm stated that AMU has completed the electrical and water service to the area; the final hooks will be waiting to be installed by Spring

time; AMU has also installed to pole lights that are currently in service that will help keep vandals away.

5. Sunnyside Ice Rink Update- Staashelm has stated the liner is now installed and filled with water; he wishes for it to open in January if the weather gets cold enough to freeze the water; Staashelm stated that Berg Electric is installing lights and outlets to serve the Ice Rink; he says in the next couple of weeks the rink will be open for the winter season.

- 1. Sunnyside Streets are closed for the season- Staashelm stated that the streets that run through Sunnyside Park are closed for the season for safety reasons; even though the streets are closed the park remains open for its normal hours; he did state that the ice rink will have extended hours to give people an opportunity to use the facility
- Shelter Reservations for 2017 will be accepted on January 1st, 2017- Staashelm stated that he will not accept shelter reservations for the 2017 year until January 1st; people will be able to reserve a shelter by either calling the office or visiting the parks and recreation website.
