- Making progress on the mandatory garbage service report. City Employee Tom Gaines had proposed an idea that Lund will be exploring further.
- Starting work on FY19 budget.

Mayor Jones advised:

- City staff is using the new reporting software a lot; hoping to launch it for public use in October
- He had received several complaints about the Mediacom office being closed; he suggested that Mediacom contact the media with information as to when it will re-open
- There will be a meeting in October for the public regarding available internet options
- Citizens need to keep their grass mowed with the recent rains
