#### **Action Items/New Business**

- 1. Schildberg Recreation Area Development Project Update
  - a. Westside Shelter Design- Staashelm presented to the board a couple of options for the shelter design; Beane suggested to have the shelter resemble the other shelters in Sunnyside with the red roof and brick columns; Staashelm told the board that the project is currently in planning phase the plan is to have the shelter completed before July of this year.
  - b. Eastside Playground- Staashelm reported to the board the playground is still stored in the shed; he will be working on scheduling a date for construction; Staashelm noted to the board the project will be a 2 day build and his plan was to try to have city employees start the build on a Friday and then have a volunteer group come in on a Saturday to finish the project; Staashelm also presented some additional ideas to help improve the area ascetically with using berm rocks and cut steel for the parking areas to give a little art to the area; it was expressed by the board that we do not need to do any of the extra stuff to improve upon the area; Krogman suggest to put those aside and leave it as an option for a donor who is looking for things to finance.
- 2. Lake 3 Trail Update- Staashelm stated the trail has the same status as last month; they are waiting for the ground to thaw and for the weather to clear up
- 3. Community Parks Project Update: Staashelm presented the feedback from City Council; Staashelm did state there was a lot of conversations on those areas, some good and some bad; but he felt that overall positive about the feedback from city council; Staashelm reported that he felt from City Council that doing a full plan for Cedar Park was the next step and doing the Mollett park in phases was the best way to go about those projects

- 4. Sunnyside Entrance Sign Update- Staashelm asked the board for guidance for this project; Staashelm stated that they could put the sign behind the columns but felt that it loses its purpose as far as aesthetics; it was suggested first by Beane to why not just tear down the pillars and install new columns for the entrance to have it match the overall theme in Sunnyside; the other board members agreed; Staashelm told the board he will contact the other parties with in the project to convey the message and reach out to ARISE to make sure we are doing our best to keep history.
- 5. Parks CIP 10 Year Plan- Priorities- Staashelm asked the board for feedback for changes that need to be done to the plan; Staashelm suggested taking off the bike park item; it was also suggested to take off the fitness park idea too, since that has been fulfilled with the Heritage house trail equipment; the board's top priority would be to finish Schildberg Recreation Area; next would be the community parks and trail system, then it would be to maintain the park facilities.
