- 4. Sunnyside Entrance Sign Update: Staashelm reported that the pillars are currently demolished; the parks department will be working with the girl scout troop in completing the signs before the season is done.
- 5. Discussion on Sunnyside park trees: The park board discussed what to do with the dead trees in Sunnyside park; it was resolved to take down the dead trees one by one in due time while planting new ones to keep up with the canopy cover.
