City Administrator Lund Presented historical property tax figures from FY 2015-2020 and project property tax figures from FY 2021-2030 showing year to year growth in property tax revenues which have averaged .84 % growth since John took office and will average 1.83% for the next ten year period. He indicated that he had no interest in reaping more cash for the city just because the city can. Tax levy is pretty flat- residential taxes went up because of the rollback. Budget will be much more complicated if property tax reform bills are passed. He also addressed the negativity in response to the street department addition.

City got its health insurance renewal with an 8.73% increase. City Clerk Barrick and he are looking into options with the. 8.73% increase.

Mayor Jones reported that because there is additional interest being expressed in purchasing the Senior Center, he is sending the issue back to Personnel & Finance. He also advised that grass is going to start growing quickly and citizens be aware and keep it mowed.

Council Member Casady asked about microphones; Nick is getting speakers.

Council Member Halder thanked everyone that showed up to Monday evening's meeting to improve Cass County.

Council Member Hayes asked the public if they had an issue and there is a problem, contact your elected officials and don't just complain amongst yourself. It doesn't solve anything.

Grace Garrett inquired about the Every 15 Minute Event held recently at the high school. She also had concerns about the vacant city lots that are for sale.

Christina Bateman emphasized contacting elected officials with questions and issues. She stated that complaining brings about division.
