The Atlantic City Council met in regular session in the Council Chambers at City Hall with Mayor Jones presiding. Council Members present were: Jimerson, Somers, Hayes, Hartkopf, Stuart, Halder, and Cord. Absent: none.

Hayes moved, Hartkopf seconded, to amend the agenda by deleting item #2.f. entitled, "Tax Abatement Application for 1604 Bryn Mawr Blvd.," and to approve the rest of the agenda as posted. All in favor.

Hartkopf moved, Jimerson seconded, to approve the consent agenda which includes: minutes of the December 3, 2014 Council Meeting, a Solid Waste Collector's Permit for Green RU, LLC., Class E Liquor Licenses for Casey's-911 Southwest Seventh Street and Casey's-701 Poplar Street, appointment of Ted Robinson to the Utility Board of Trustees for the term ending April 1, 2015, appointment of Kevin Weiser to the Community Promotion Commission for the term ending July 1, 2015, and Tax Abatement Application for 904 Mulberry. All in favor.

Mayor Jones presented Police Sergeant Paul Wood an award for ten years of service.

Jimerson moved, Hartkopf seconded, to approve a 28E Agreement between the City of Atlantic and the City of Marne for mutual aid with regard to fire protection. All in favor.

Hartkopf moved, Hayes seconded, to adopt resolution #24-14 entitled, **"RESOLUTION AMENDING SERIES 400 OF THE CITY'S PERSONNEL POLICY MANUAL."** All in favor.

Jimerson moved, Somers seconded, to pass ordinance #955 entitled, **"AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF ATLANTIC, IOWA, BY ADDING A NEW CHAPTER NUMBERED 56 TITLED 'MOWING OF PROPERTIES,' "** on second reading. All in favor.

Jimerson moved, Hartkopf seconded, to suspend the rules and place ordinance #955 on the third reading. All in favor.

Jimerson moved, Somers seconded, to pass ordinance #955 on the third and final reading. All in favor.

City Administrator John Lund reported on a number of items including: the change of employment for Rolly Parrott from part time to full time, a recent Planning & Zoning Commission meeting, and upcoming urban forestry training by the Iowa Department of Natural Resources.

Council Committee Reports were given as follows: Cord-Community

Promotion and Chamber of Commerce; Halder-Cass/Atlantic Development and Library; Hartkopf-Airport; Somers-Cass County Public Safety.

Hayes moved, Halder seconded, to approve the bills totaling \$117,039.02. All in favor.

Somers moved, Hartkopf seconded, to approve the Clerk, Treasurer, Budget, General Ledger, Revenue, Airport, and Volunteer Fire Department reports for November. All in favor.

Jimerson moved, Halder seconded, to adjourn at 5:56 p.m. All in favor.
