Administrator's Report:

• Community Protection meeting end of July; follow up meeting Aug 31 at 3 pm

- Working a lot with land committee and talking with finance attorney, engineer to come to a reasonable balance towards the housing project. Project will be beneficial to the city in the long term. First phase will be something workable for the city, not taking any risk.
- Major changes to the budget process for FY23, especially general fund departments. Too many changes that have happened in the legislature to continue on the way the city has been.

Mayors report:

- Seventh street curbs were cleaned last week by park & rec and code enforcement as a one-time courtesy to property owners. This is setting the standard for maintaining curbs whether you are a resident or a business. Please maintain the weeds on your property as a part of your property clean up. Do not allow weeds to grow over the curb. Code enforcement is giving 24-hour notice for grass and weeds, and if nothing is done in 24-hours, the city will proceed with violations.
- Atlantic Fest had a large turnout; Chamber of Commerce was please with the large crowd.

City Clerk Barrick updated the Council with the denial of the liquor license for Weitzel's. Alcoholic Beverages Division has notified Weitzel and informed him that he may file an appeal, which he has done. Barrick then read the appeal. Next step will be for the ABD Administrative Judge to schedule a telephone hearing to include the city and Mr. Weitzel. Mayor Garrett commented that she would reiterate right there that we are enforcing code on both businesses and residences, and that citizens can be assured we are working to improve our community
