Entry deadline

Booth fees

No fees due at the time of application. Mobile **Food Permit is required to be obtained from Atlantic City Hall.**

Food vendor policies

UNIQUE FESTIVAL FOODS ARE THE BEST RECEIVED AND ENCOURAGED. Vendors understand there may be other vendors selling like product. The AtlanticFest Committee reserves the right to decline fund raising activities that do not fit

the appropriateness of the festival. No sectarian material can be dispensed.

A **certificate of insurance** is required with your application as well as the appropriate **food permits and licensing** on display and current on the day of the event. Vendor is responsible for meeting all regulations in accordance with the county inspector. **Mobile Food Vendor Permit is required to be obtained by Atlantic City Hall (23 E 4th Street, Atlantic.)**

Booths need to be in place prior to 8 a.m. and open by 11 am . All concessionaires are asked to operate until 5 p.m. The Concessionaire must provide his/her own display equipment. If the weather is dry, you may drive on park ground to unload but then additional vehicles not necessary for concession stands need to be removed immediately. To avoid delays in the Road Race, all vehicles must be removed from 6th Street by 7:30 a.m. No exceptions. Please unload equipment before that time or use Chestnut Street.

The event is rain or shine and fee will not be refunded if the entire festival is cancelled due to inclement weather.

Beverage sales

Vendors are NOT allowed to sell beverages. The Chamber will retain all beverage sales including, but not limited to, pop, water, coffee, tea and other non-carbonated drinks.
